FEES AND PAYMENTS

Listed below are services provided and fees charged by Dr. Quesenberg. The specific services you will receive and fees you will pay will be specified in a Payment Agreement that must be signed by Dr. Quesenberg and the patient or patient's sponsor. A copy of the signed agreement will be given to the patient or the patient's sponsor.

1. DIAGNOSTIC INTERVIEW:.....\$175

Patient and family members are interviewed in a 50 minute session. Medical and/or school records are reviewed prior to the 50 min. session. An opinion and tentative plan to resolve the problem is offered. *NOTE: If a Comprehensive Assessment or ADHD Evaluation is recommended after the interview, the \$175 fee for this service is subtracted from the fees for the Comprehensive or ADHD Evaluations.*

2. COMPREHENSIVE ASSESSMENT:

Ages 3 through 16 years.....\$854 *NOTE: These can be paid in 2 or 3 monthly payments. A 3 payment plan must be secured with a VISA or MASTERCARD.*
Ages 17 years and older.....\$975

A battery of tests to identify learning, emotional, behavioral, and/or developmental problems in children, adolescents, and adults is administered. This service involves 3 to 4 hours of testing, about 1 hour of test and historical data analyses, and a 1 hour feedback session with the person tested and/or his parents or guardians. After the feedback session a formal written report is prepared and sent to the person tested and/or his legal guardian.

3. SPECIFIC ASSESSMENT:.....\$150 / Hour

Measures of specific psychological functions (e.g. intelligence, achievement, personality traits, etc.) are taken, analyzed, and reported to the patient and/or his guardian. Fees vary, depending on the test(s) given and whether feedback is given in a meeting or a written report. A common request, for example, is a parent requesting that his child be tested on an IQ test to see if he or she qualifies for admission to a gifted and talented program; the cost of administering the SB-V or WISC-IV for such a purpose is \$260.

4. ATTENTION DEFICIT EVALUATION:

Ages 3 through 16 years.....\$541 *NOTE: These can be paid in 2 or 3 monthly payments. A 3 payment plan must be secured with a VISA or MASTERCARD.*
Ages 17 years and older.....\$625

Persons suspected of having ADHD are interviewed and tested on continuous performance, personality, intelligence, and achievement tests. Historical data and behavior ratings are considered along with test data in diagnosing the condition. If specific school learning difficulties have coexisted with the suspected ADHD symptoms, this procedure will be insufficient. A COMPREHENSIVE ASSESSMENT to formally identify a possible learning disability or some other condition should be done instead.

5. ADHD MEDICATION EFFECTS TESTING:..... \$ 114 / approx. 45 min. session

Scores obtained during medicated and non-medicated states are obtained from the patient to determine if the medication prescribed for ADHD has normalized measures of attention and impulsivity.

6. INDIVIDUAL/COUPLES/OR FAMILY PSYCHOTHERAPY:... \$ 115 / 50 min. session.

A treatment program for behavioral or emotional problems is planned and implemented in office sessions lasting 50 minutes; the last 10 minutes of the therapy hour is used for recording progress notes. Total family involvement and cooperation is mandatory.

7. GROUP PSYCHOTHERAPY:.....\$55 / Hour

Persons with common concerns and similar problems share them with group members and Dr. Quesenberg in 1 1/2 hour to 2 hour session. Problems covered include defiant/hyperactive children, depression in parents, and conflicts leading to and following divorce. Solutions are proposed and monitored.

8. SCHOOL-BASED INTERVENTION:.....\$115 / Hour

This service involves implementation of a treatment plan formulated in the school setting, and on-site consultation with teachers regarding the client's program.

9. CONSULTATION & COMMUNICATIONS :.....\$2 /Minute (By Telephone, In Person, or By Letter/Memo)

Specifically requested information is presented and explained to school, medical, governmental, legal, or managed-care personnel

10. CogMed WORKING MEMORY TRAINING for ADHD & LD.....\$1500.00 or 25 hours

The trainee, coping with ADHD and/or LD, works on a home- or school-based computer, 45 min. each day, 5 days a week, for 5 weeks. Performance data is uploaded via the Internet, to a CogMed server. The trainee is monitored and coached by Dr. Quesenberg, using downloaded performance data and weekly telephone consults with the trainee's parent or with a school-based assistant. This service delivery model, which does NOT require weekly office visits, was developed and perfected in Sweden.

****NOTE: The fee for CogMed training can be paid in full, or in 3 installments. The 3 payment plan must be secured with a VISA or MASTERCARD, and made as follows: \$800 at startup; \$350 due 30 days after startup, and \$350 due 60 days after startup.**
